Ladies and Gentlemen:





AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a certain Petition dated July 11, 1978, requesting annexation of territory hereinafter described was duly presented to the City Council on the 17th day of July, 1978; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described, is two acres of unplatted land and no part of which is included within the limits of an incorporated city, village or burough; and

WHEREAS, the Petition was signed by all of the owners of said land; and

WHEREAS, no objection to the annexation has been received from any governing body whose boundaries abut or are included in the boundaries of the land to be annexed; and the Municipal Board has permitted the City to proceed, and

WHEREAS, no hearing is required by law on the proposed annexation; and

WHEREAS, the land described in the Petition abuts the City limits of the City of Glencoe; and therefore, the Council of the City of Glencoe, Minnesota ordains:

Section 1. (1) That the annexation will be to the best interests of the City and territory affected;

(2) That the territory described herein abuts upon the City limits and is urban or suburban in character; and

(3) That none of the said territory is included within the limits of any city, village or burough.

Section 2 - Territory Annexed. The corporate limits of the City are extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it originally had been a part thereof:

Beginning at a point 939 feet south of the northeast corner of the west half of the southeast quarter of Section 11, Township 115, North of Range 28 West, County of McLeod, State of Minnesota; thence west 384.65 feet to a point 33 feet east of center line of County Road No. 2; thence southeasterly 592 feet; thence north 453 feet to point of beginning, containing 2 acres.

Section 3 - Filing. The City Clerk is hereby directed to file the certified copy of this ordinance with the Minnesota Municipal Board, the Secretary of State, the County Auditor, and the County Recorder.

Section 4 - Effective Date. This ordinance takes effect upon its passage of publication and the filings of the certified copies as directed in Section 3.


