ORDINANCE NO. 1978-1-F

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MELROSE, STEARNS COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition, dated July 31, 1978, requesting annexation of the territory herein described, was duly presented to the Council on the 5th day of September, 1978, and

WHEREAS, the quantity of land embraced within the area to be annexed and which is herein described, is approximately Thirty-nine and sixty-seven hundredths (39.67) acres of unplatted land; and

WHEREAS, the Petition was signed by all the owners, and
WHEREAS, the Town Board of Grove Township has expressly
waived all objections to this annexation by Resolution adopted at
a meeting held September 11, 1978, and

WHEREAS, no objections of the annexation have been received from the County Board, or the governing body of any municipality, whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City of Melrose at the south boundary.

THE COUNCIL OF THE CITY OF MELROSE, MINNESOTA, ORDAINS:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is or is about to become urban or suburban in character; (3) that none of said territory is now located within the limits of any city, village, or borough.

Section 2. Territory annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All that part of the West Half of the Southeast Quarter (W½ SE½) of Section Three (3), Township One Hundred Twenty-five (125) North, of Range Thirty-three (33) West, lying Northerly and Westerly of County State Aid Road No. 13, except that part platted as MEADOWLARK PARK, in Stearns County, Minnesota.

LESS AND EXCEPT: That part of the SE½ of Section 3, Township 125 North, Range 33 West, Stearns County, Minnesota, described as follows:- Beginning at the Southwest corner of MEADOWLARK PARK; Thence East (assumed bearing) along the South line of said MEADOWLARK PARK 143 feet to the SE corner of Lot 12 thereof; thence South 41° East 90 feet, more or less, to the NWly right of way line of Public Road; thence SWly on said right of way line to the West line of said SE½; thence North on the West line of said SE½ to the point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
