ORDINANCE NO. 3, 2ND SERIES

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE

THE CITY OF PIPESTONE ORDAINS:

Section 1. The land described as follows, to-wit:

A tract of land in the Northwest Quarter of Section 7, Township 106 North, Range 45 West, described as follows:

Beginning at a point on the North right-of-way line of the Chicago, St. Paul, Milwaukee and Omaha Railroad, and 100 feet East of the West line of Section 7; thence northerly and parallel to said West line of Section 7 to the South right-of-way line of Trunk Highway #23; thence northeasterly along said right-of-way line of Trunk Highway #23 a distance of 75 feet more or less to the center line of Judicial Ditch #1; thence southeasterly along the center line of Judicial Ditch #1 for a distance of 150 feet; thence southerly to the North right-of-way line of the Chicago, St. Paul, Milwaukee and Omaha Railroad; thence 250 feet to the point of beginning, said tract containing .82 acres of land, more or less, and is subject to easements of record.

is hereby annexed to the City of Pipestone and the corporate limits of the City of Pipestone are hereby extended to include same.

Section 2. This ordinance shall take effect and be in full force from and after its passage and publication.
