ORDINANCE NO. 84

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AMBOY TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated May 12, 1978, requesting annexation of the territory hereinafter described was duly presented to the council on the 12th day of May, 1978; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 1.487 acres of unplatted land, no part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board of the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the south boundary thereof;

The Council of the City of Amboy, Minnesota, ordains:

SECTION 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city or borough.

SECTION 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

A tract of land in the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota, to-wit:

Commencing at the Southwest corner of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota: thence North 89° 32' 51" East (assumed bearing) along the South line of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) a distance of 33 feet to the east right-of-way line of the township road; thence continuing North 89° 32' 51" East along said South line of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) a distance of 370.74 feet to the northerly extension of the East line of Block 3 of Amboy, Blue Earth County, Minnesota according to the plat on file and of record in the office of the Blue Earth County Recorder; thence North 0° 07' 00" West along the northerly extension of the East line of Block 3 a distance of 138.26 feet; thence South 89° 49' 44" West parallel with the North line of Block 3 a distance of 370.45 feet to the east right-of-way line of said township road; thence continuing South 89° 49' 44" West parallel with the North line of Block 3 a distance of 33 feet to the West line of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) of Section 23; thence South 0° 00' 00" West along said West line of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) a distance of 140.25 feet to the point of beginning. Subject to an easement for public roadway right-of-way along the West line of the herein described tract.

A tract of land in the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) of Section 23, Township 105 North, Range 28 West in Amboy, Blue Earth County, Minnesota, to-wit:

Commencing at the Northwest corner of Block 3 of Amboy, (now City of Amboy) Blue Earth County, Minnesota according to the plat on file and of record in the office of the Blue Earth County Recorder; thence North 0° 06 minutes 13" West along the northerly extension of the West line of Block 3 a distance of 20 feet to the point of beginning; thence continuing North 0° 06' 13" West along the northerly extension of the West line of Block 3 a distance of 25.11 feet to the North line of the Southwest Quarter (SW $\frac{1}{4}$ ) of the Northwest Quarter (NW $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota; thence North 89° 32' 51" East along said North line of the Southwest Quarter of the Northwest Quarter of the Northeast Quarter (NE $\frac{1}{4}$ ) a distance of 330.70 feet to the northerly extension of the East line of Block 3; thence South 0° 07' 00" East along the northerly extension of East line of Block 3 a distance of 28.74 feet to a point lying 20 feet northerly of the Northeast corner of Block 3; thence North 89° 49' 44" East parallel with the North line of Block 3 a distance of 330.70 feet to the point of beginning.

SECTION 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

SECTION 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
