### ORDINANCE NO.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERTVILLE, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS OF ALBERTVILLE.

WHEREAS, a certain Retition dated July 17, 1978, requesting annexation of the territory hereinafter described was duly presented to the council on the 17th day of July, 1978; and

WHEREAS, the Petition was signed by all owners of said territory; and

WHEREAS, no objections to the annexation have been recieved by the council from the Town Board, or the governing body of any municipality whose boundaries abut the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts the city limits at the easterly boundaries thereof;

The council of the City of Albertville, Minnesota ordains:

Section 1. The city council hereby determines (1) that the territory decribed herein abuts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

See Exhibit A attached hereto

Section 3. The city clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Frankfort Town Elerk, and the Wright County Auditor.

Section 4. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

The East Half of the Southeast Quarter of Section 1, Township 120, Range 24, Wright County, Minnesota, EXCEPT the four following described tracts:

PARCEL 1

Commencing at the Southwest corner of the Southeast Quarter, Section 1, Township 120, Range 24; thence East on the South line of said Southeast Quarter a distance of 17.12 chains to the point of beginning; thence continuing East along said South line a distance of 600 feet; thence North 773 feet; thence West 600 feet; thence South 773 feet to the point of beginning.

## PARCEL 2

That part of the Southeast Quarter of the Southeast Quarter, Section 1, Township 120, Range 24, described as follows:

Beginning at the Southeast corner of said Section 1; thence North along the Section line a distance of 208.7 feet; thence West parallel with the South line of said Section 1 a distance of 208.7 feet; thence South parallel with the East line of said Section 1 a distance of 208.7 feet to the South line of said Section 1; thence East along said South line a distance of 208.7 feet to the point of beginning.

### PARCEL 3

All that part of the Southeast Cuarter of the Southeast Quarter, Section 1, Township 120, Range 24, Wright County, Minnesota, described as follows:

Beginning at a point on the South line of said Section 1 a distance of 431.7 feet West of the Southeast corner thereof; thence North 89 degrees 30 minutes West along said South line of Section 1 a distance of 253.7 feet; thence North 0 degrees 40 minutes East 242.1 feet; thence North 89 degrees 09 minutes East 254.85 feet; thence Southerly 248.1 feet, more or less, to the point of beginning.

## PARCEL 4

The North 208.7 feet of the South 417.4 feet of the East 208.7 feet of the Southeast Quarter of the Southeast Quarter, Section 1, Township 120, Range 24.

That part of the Southeast Quarter of the Northeast Quarter of Section 1, Township 120, Range 24, Wright County, Minnesota, lying Southerly of the Southerly right of way line of the Burlington Northern Railroad.

All that part of the Southwest Quarter of the Northwest Quarter and of the Northwest Quarter of the Southwest Quarter lying Southerly of the Southerly right of way line of the Burlington Northern Railroad except the South 82.5 feet of said Northwest Quarter of the Southwest Quarter, all in Section 6, Township 120, Range 23, Wright County, Minnesota.

That part of the East Half of the Southwest Quarter of Section 6, Township 120, Range 23, Wright County, Minnesota, lying Southerly of the Southerly right of way line of the Burlington Northern Railroad and Westerly of the following described line:

> Commencing at the Southwest corner of said East Half of the Southwest Quarter; thence Morth along the West line of said East Half of the Southwest Quarter, a distance of 1357.85 feet to the actual point of beginning of the line to be described hereinafter referred to as Line A: thence Northerly along a tangential curve, concave to the East having a radius of 4330.98 feet and a central angle of 9 degrees 22 minutes 30 seconds, a distance of 708.65 feet; thence Northerly tangent to said curve, a distance of 419.30 feet to the said Southerly right of way line and terminating thereat.

An 80.0 foot tract of land in that part of the Southeast Quarter of the Northeast Quarter of Section 1, Township 120, Range 24, Wright County, Minnesota, the centerline of said tract described as follows:

Commencing at the Southwest corner of said Southeast Quarter of the Northeast Quarter; thence North along the West line of said Southeast Quarter of the Northeast Quarter a distance of 1011.46 feet to the Southerly right of way line of the Burlington Northern Railroady thence Southeasterly along said Southerly right of way line a distance of 560.0 feet; thence Kortheasterly deflecting 90 degrees left a distance of 100.C feet to the Northerly right of way line of the Burlington Northern Railroad and the actual point of beginning of said centerline; thence continue Northeasterly along the last described course a distance of 180.0 feet; thence Northerly along a tangential curve concave to the West having a radius of 310.66 feet a distance of 350.0 feet, more or less, to the Southerly right of way line of Interstate Highway Number 94 and said centerline there terminating the side lines of said tract are to be lengthened or shortened to terminate on the said Southerly right of way line of Interstate Highway Number 94.
