ORDINANCE NO. 68

An Ordinance extending the corporate limits of the City of New London, a municipal corporation of the State of Minnesota, to include certain lands not exceeding 200 acres.

WHEREAS, a petition has been filed with the governing body of the City of New London, a municipal corporation of the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of New London, Minnesota, and

WHEREAS, it is proposed to annex by virtue hereof to the said City of New London, said property, all of which said property is in Mandiyohi County, State of Minnesota, and

WHEREAS, the said property to be annexed consists of approximately 14.24 acres, more or less, described as follows, to-wit:

All that part of the East Half of the Southeast Quarter (E1/2 SE1/4) of Section Nine (9), Township One Hundred Twenty-one (121). Range Thirty-four (34), described as follows:

Commencing at the Southeast corner of said Section Nine (9); thence on an assumed bearing of North, along the East line of said Section Nine (9), a distance of 1314.00 feet to the point of beginning of the tract herein described; thence on a bearing of West, 198.00 feet; thence on a bearing of South, 400.00 feet; thence on a bearing of West, 428.00 feet; thence on a bearing of West, 428.00 feet; thence on a bearing of Worth, 1175 feet, more or less, to the South bank of the Crow River; thence East along the South bank of the Crow River to the intersection with the East line of Section Nine (9); thence on a bearing of South, along last said line, 665 feet, more or less, to the point of beginning.

NOW, THEREFORE, the City Council of the City of New London hereby determines, ordains and declares as follows:

SECTION 1. Best Interest of the City of New London and Area to be Annexed. That the annexation will be to the best interest of the City of New London, Minnesota, and of the territory affected.

SECTION 2. Abuts on City Limits. That the property above described abuts on the city limits, and is so conditioned as property to be subject to city government.

SECTION 3. Annexation. That the said property is hereby annexed to, and included within, the City of New London, Minnesota, as effectually as if it had oxiginally been a part thereof.

SECTION 4. Effective Date. This ordinance shall be filed and shall take affect and be in full force and effect from and after filing a certificate thereof with the Minnesota Municipal Board, the County of Kandiyohi, Minnesota, the Town Clerk of the Township of New London, County of Kandiyohi, State of Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
