ORDINANCE NO 164

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLAYTON TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated 6 November 1978, requesting annexation of the territory hereinafter described was duly presented to the council on the 20th day of November, 1978, and

WHEREAS, the quanity of land embraced within the area described in the part of and bounded as described is 3.3 acres more or less of platted land, no part of which is included within the limits of an incorporated city or borough; and

WHEREAS, the petition was signed by the sole owner; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundries abut upon the boundries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the northern boundry thereof;

NOW THEREFORE, THE COUNCIL OF THE CITY OF SLAYTON, MINNESOTA, DOES ORDAIN:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Block 1, North-Side Addition, Slayton Township, Murray County, Minnesota.

Said parcel contains 3.3 acres more or less, and is subject to existing easements of record

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


Block I North Side Addition, Slayton Township, Murray County, Minnesota.


