

IN THE MATTER OF THE APPLICATION
BY THE HONORABLE DANA NICHOLSON
JUDGE OF DISTRICT COURT, FOURTH
JUDICIAL DISTRICT, STATE OF
MINNESOTA, FOR RETIREMENT ON
JANUARY 2, 1979, PURSUANT TO
PROVISIONS OF M.S. 490.126,
SUBDIVISION 2.

WHEREAS, Judge Dana Nicholson has made application to the undersigned Governor Rudy Perpich in a letter dated July 10, 1978 for full retirement at 8:00 a.m. on January 2, 1979, and

WHEREAS, the said Judge Dana Nicholson will have served continuously as a judge of the Minneapolis Municipal Court commencing on January 10, 1952 through June 30, 1959, and thereafter as a District Judge since July 1, 1959, to the effective time of his retirement, and

WHEREAS, the said Judge Dana Nicholson reached the age of 69 years on March 7, 1978, and

WHEREAS, M.S. 490.125, Subdivision 2, requires the Governor to make a written order accepting such retirement, and

WHEREAS, the necessary legal requirements will have been met for such retirement on January 2, 1979,

NOW, THEREFORE, I, Rudy Perpich, Governor of the State of Minnesota, acting pursuant to the aforementioned statute, do hereby direct the retirement of Judge Dana Nicholson, by this written Order, such retirement to be effective at 8:00 a.m. on January 2, 1979, regardless of when this Order may be filed in the Office of the Secretary of State, and do further order that retirement benefits for Judge Dana Nicholson shall commence as provided by law on January 2, 1979.
