The Clerk is to notify Mr. Nelson of the decision.

There was a question as to what Mr. Jemmings had first made his building permit for last month. It was felt that he was going beyond his permit. The Mayor was to contact him to find out.

Gilbert Larsen approached the Council to see if he could quit night policing. He says that he gets very uncomfortable and uneasy when he works nights like that. The Council made no decision but took it under advisement.

The City Clerk informed the Council that Wanda has now returned the Police Mutual Aid Agreement. This then will be filed with the others already signed.

After going over the Summary Statement of Voters for the Regular City Election, Councilman Welter made the motion, seconded by Councilman Kopischke that the following Resolution be read and moved for its adoption:
