Sales at the store. For the month of October, Gross Sales were \$18,452.00 as compared to \$17,823.00 or up \$629.00 or 3.4%. Gross Sales for the year to date were \$189,986.00 as compared to \$171,023 or up \$18,963 or 10.0%.
