ORDINANCE NO. 18

RELATING TO THE ANNEXATION OF CERTAIN
PROPERTY OWNED BY THE CITY OF CONGER.

Councilman Laurena Wickman offered the following Ordinance:

The City Council of the City of Conger does ordain:

Section 1. The City of Conger is the owner in fee of certain pre-
mises now lying without the corporate limits, described as follows:

Beginning at a point on the South right of way line of the C.R.I. & P.R.R. in the Village of Conger, which point is 12 feet West of the Northwest corner of Lot 4, Block 1 in the Village of Conger; thence 680' South along the West line of the alley West of Blocks 1 & 2 in the Village of Conger to a point which is 12 feet West and 66 feet South of the Southwest corner of Lot 1, Block 2; thence 387.2 feet West at a deflection angle of $89^{\circ}50'$ right on a westerly extension of the southerly line of a street; thence 514 feet northerly at a deflection angle of $90^{\circ}10'$ right on a line parallel to the West line of Blocks 1 & 2; thence 273.72 feet northeasterly at a deflection angle of $52^{\circ}30'$ right to the southerly right of way line of the C.R.I. & P.R.R.; thence 170.04 feet easterly at a deflection angle of $37^{\circ}20'$ right along said southerly right of way line of the C.R.I. & P.R.R. to the point of beginning, being part of the Northeast Quarter of the Northeast Quarter of Section 25, Township 102 North, Range 23 West, and commencing at a point which is 12 feet West of the Southwest corner of Lot 1, Block 2, Miller's Addition to the Village of Conger, as platted and recorded; thence South 66 feet; thence East 220 feet; thence North 66 feet to the Southwest corner of Lot 1, Block 3 of said Addition; thence West 220 feet to the point of beginning.

Section 2. The property is used for an authorized City purpose.

Section 3. The property is not the part of any incorporated municipality, but does abut on the current corporate boundary lines and is adjacent to the corporate limits of the City of Conger.

Section 4. The City of Conger does hereby order and ordain that the premises described in Section 1 are hereby deemed and declared to be a part of the City of Conger and are hereby annexed thereto.
