ORDINANCE NO. 178

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LE CENTER TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON AND SURROUNDED BY THE LIMITS OF THE CITY OF LE CENTER.

Whereas, the territory described below is not presently within the corporate limits of any incorporated city; and

Whereas, this territory abuts upon and is surrounded by the SOUTHWESTERN BOUNDARY THEREOF the corporate limits of the city and is deemed to be urban in character;

The corporate limits of the city of Le Center are hereby extended to include the platted property described as follows:

All that part of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of section No. 29, Township No. 111 North, Range No. 24 West, Le Sueur County, Minnesota described as follows: Beginning at a point 320 ft. West and 75 ft. North of the South $\frac{1}{4}$ corner of said Section No. 29 thence West 175 ft., thence North 189 ft., thence West 165 ft. thence North 100 ft. thence East 340 ft. thence South 128 ft., thence East 203 ft. thence South 100 ft., thence West 203 ft., thence South 61 ft. to the place of beginning. Containing 1.93 acres.

This ordinance takes effect upon its passage and publication and the filing of certified copies as directed by law.
