ORDINANCE NO. 154

New Richland

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF NEW RICHLAND TO INCLUDE CERTAIN
UNPLATTED LAND

Introduced By Stan Stabow

WHEREAS, a Petition has been filed with the governing body of the City of New Richland, Minnesota, signed by the owner of the following described real estate to have such land included within the City of New Richland, Minnesota:

The part of the Southeast Quarter of the Northwest Quarter (SE 1/4 of NW 1/4) of Section Seventeen (17), Township One Hundred Five (105) North, Range Twenty-two (22) West, described as; Commencing at the southeast corner thereof (the center of said section) and thence west on the south line Three Hundred Seventy-eight (378) feet; thence north parallel to the east line thereof Five Hundred (500) feet; thence east parallel to the south line thereof Three Hundred Seventy-eight (378) feet to the east line thereof; and thence south on the said east line Five Hundred (500) feet to the place of beginning, containing 4.34 acres, more or less and being subject to highway easements and utility rights of way and ditch and drainage easements of record.

The quantity of land embraced within the foregoing description and bounded as described is 4.34 acres.

THE CITY OF NEW RICHLAND DOES ORDAIN:

Section 1. That the annexation will be to the best interests of the City of New Richland and to the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 2. That the property hereinbefore described be and the same is hereby annexed to and included in the City of New Richland as effectually as if it had originally been part thereof.

Section 3. That this Ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the Clerk of New Richland Township, the County Auditor and the Secretary of State and from and after its passage and publication.


