ORDINANCE NO. 51

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY  
OF STACY TO INCLUDE CERTAIN UNINCORPORATED PROPERTY  
OWNED BY THE CITY AND ABUTTING UPON THE CITY LIMITS

WHEREAS, the territory described below is not presently within  
the corporate limits of any incorporated city, village or borough, and

WHEREAS, the territory abuts upon the corporate limits of the  
City of Stacy at the South boundary thereof and is deemed to be urban in  
character, and

WHEREAS, this territory is owned in fee by the City of Stacy;  
THE CITY COUNCIL OF THE CITY OF STACY, CHISAGO COUNTY, MINNESOTA,  
ORDAINS:

Section 1. The corporate limits of the City of Stacy are hereby  
extended to include that property described as follows, which is now owned  
by the City:

Lots 14 and 15, Block 1, SUNRISE ESTATES,  
according to the plat thereof on file and  
of record in the office of the County Recorder  
in and for Chisago County, Minnesota.

Section 2. The City Clerk is directed to file certified copies  
of this Ordinance with the Secretary of State, the County Auditor of Chisago  
County, the Town Clerk of the Town of Lent, Chisago County, Minnesota,  
and the Minnesota Municipal Board.

Section 3. This Ordinance takes effect upon its passage and  
publication and the filing of certified copies as directed in Section 2 hereof.

14 day of November, 1978.
