ORDINANCE NO. 187

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE **CITY** OF WELLS TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition dated September 20, 1978, requesting annexation of the territory hereinafter described was duly presented to the Council on the 20th day of September, 1978; 1

AND WHEREAS, the Petition was signed by all owners;

AND WHEREAS, no objections to the annexation have been received from the Town Board, or the government body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

AND WHEREAS, the land described in the petition abuts on the City limits at the East and South boundaries thereof.

NOW THEREFORE, the Council of the City of Wells, Minnesota, ordains:

1. The City Council hereby determines that the territory described herein abuts upon the City limits and is or is about to become urban or suburban in character; and that none of the territory is now included within the limits of any City.

2. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof:

A tract of land in the South Half of the Southwest Quarter of Section 9, Township 103 North, Range 24 West in Faribault County, Minnesota described as follows:

Commencing at the Southeast corner of the Southwest Quarter of Section 9, Township 103 North, Range 24 West in Faribault County, Minnesota; thence North 0 degrees 00 minutes 00 seconds East (assumed bearing) along the East line of the Southwest Quarter a distance of 986.17 feet to the point of beginning; thence continuing North 0 degrees 00 minutes 00 seconds East along the East line of the Southwest Quarter a distance of 333.28 feet to the Northeast corner of the Southeast Quarter of the Southwest Quarter; thence Morth 89 degrees 23 minutes 24 seconds West along the North line of the Southeast Quarter of the Southwest Quarter a distance of 337.00 feet; thence South 0 degrees 00 minutes 00 seconds West along the east line of Hansen's First Country Club Addition to the Village (now City) of Wells, Minnesota, as monumented, according to the plat on file and of record in the office of the Faribault County Recorder a distance of 297.19 feet to a point 290.00 feet south of the Northeast corner thereof; thence North 89 degrees 12 minutes 24 seconds West parallel with the north line of Hansen's First Country Club Addition and north line of Hanse Second Country Club Addition to the Village (now City) of Wells, Minnesota, as monumented, according to the plat on file and of record in the office of the Faribault County Recorder a distance of 1835.12 feet to a point 290.00 feet south of the northwest corner of Hansen's Second Country Club Addition; thence South 0 degrees 00 minutes 00 seconds West a distance of 35.00 feet; thence South 89 degrees 12 minutes 24 seconds East parallel with the north line of Hansen's Second Country Club Addition and north line of Hansen's First Country Club Addition a distance of 2172.12 feet to the point of beginning

The above area constitutes approximately 4.05 acres, more or less.

3. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk and the County Auditor.

4. This Ordinance takes affect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the Ordinance by the Minnesota Municipal Board.
