ORDINANCE NO. 102

AN ORDINANCE ANNEXING LANDS TO THE CITY OF
ZUMBROTA

THE CITY COUNCIL OF ZUMBROTA ORDAINS:

That pursuant to Minnesota Statutes Section 414-033, Subd. 5,
that the following described premises is hereby annexed to and incorpo-
rated within the City of Zumbrota to-wit:

All that part of the Southeast One Quarter (SE $\frac{1}{4}$) of the Northeast
One Quarter (NE $\frac{1}{4}$) of Section 26, Township 110 North, Range 16
West, lying southwesterly of the southwesterly right-of-way
line of U. S. Highway Number 52, less a tract of land lying
southwesterly of the Chicago, Milwaukee and Pacific Railway
Company's southwesterly right-of-way line; containing 37.41
acres, more or less, Goodhue County, State of Minnesota.

and

All that part of the Southwest One Quarter (SW $\frac{1}{4}$) of the Northwest
One Quarter (NW $\frac{1}{4}$) of Section 25, Township 110 North, Range 16
West lying westerly of the westerly right-of-way line of U. S.
Highway Number 52; containing 4.62 acres, more or less, Goodhue
County, State of Minnesota.

and

That part of the Southwest Quarter (SW $\frac{1}{4}$) of Section 25, Township
110 North, Range 16 West, described as follows: Commencing at
the Northwest corner of said Southwest Quarter (SW $\frac{1}{4}$), thence
S-0 degrees 25' E 33.00 feet along the west line of said Southwest
Quarter (SW $\frac{1}{4}$) to the point of beginning of the tract to be described,
said point being the South right-of-way line of the Township Road;
thence S-89 degrees 50' E 208.72 feet along said south right-of-way
of said Township Road to the Westerly right-of-way line of U. S.
Highway Number 52; thence S-53 degrees 30' 30" E 273.93 feet
along said westerly right-of-way line of said Highway 52; thence
S-17 degrees 11' E 1195.94 feet along said westerly right-of-way
line of said Highway 52 to the northerly right-of-way line of the
Chicago, Milwaukee, St. Paul and Pacific Railroad Company; thence
northerly and westerly along a curve to the right of radius 5679.58
feet, and arc distance of 321.37 feet (long chord = 321.30 feet,
long chord bearing N-50 degrees, 10' 24" W) along said Northerly
right-of-way line of said Railroad; thence N-48 degrees 31' W
708.79 feet along said Northerly right-of-way line of said Railroad
to the said West line of said Southwest Quarter (SW $\frac{1}{4}$); thence N-0
degrees 25' W 630.83 feet along the said West line of said Southwest
Quarter (SW $\frac{1}{4}$) to the point of beginning. Containing 9.96 acres,
more or less, Goodhue County, Minnesota.


