ORDINANCE NO. 303

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN.

The City Council of the City of Staples does ordain as follows:

Section 1.

The following described real estate is owned by the City of Staples and presently abuts the city limits of the City of Staples:

The Northwest Quarter of the Southwest Quarter (NW4 OF SW4) of Section 35, Township 134, Range 33 (Wadena County, Minnesota), including abutting streets, alleys and roadways.

Section 2.

The City Council hereby determines that it would be in the best interests of the City of Staples to annex the above described real estate to the City of Staples, and that the land is urban in character and is so conditioned as properly to be subjected to city government.

Section 3.

The City of Staples, Minnesota, in accordance with Minnesota Statutes Section 414.03 (subd. 2), therefore, hereby ordains and declares that the property hereinbefore described be, and the same hereby is, annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been part thereof.

Section 4.

This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Thomastown Township, the Wadena County Auditor, and the Minnesota Secretary of State.
