ORDINANCE NO. 69

AN ORDINANCE ANNEXING REAL ESTATE TO THE CITY OF TYLER.

The City Council of the City of Tyler does ordain that:

WHEREAS, that certain real estate is owned by the City of

Tyler and certain other real estate is entirely surrounded by

real estate which is part of the City of Tyler, and

WHEREAS, the City of Tyler desires to annex said real estate to the City of Tyler,

NOW, THEREFORE, the City Council of the City of Tyler ordains that the following described real estate, including the abutting streets, highways, and rights of way are annexed and incorporated into the City of Tyler, Minnesota:

Parcel #1 - A parcel of land located in the Northeast Quarter (NE%) of Section Nine (9), Township One Hundred Nine (109) North, Range Forty four (44) West of the 5th P.M., Hope Township, Lincoln County, Minnesota, being more particularly described as follows: Commencing at the Northeast corner of said Section; thence West, assumed bearing, along the North line of said Section a distance of 1785.61 feet to the point of beginning of this description; thence South 01 degrees 13 minutes 39 seconds East, parallel with the East line of said Section, a distance of 1327.84 feet; thence West, parallel with said North Section line, a distance of 350.04 feet; thence North 01 degrees 13 minutes 39 seconds West, parallel with said East Section line, a distance of 1327.84 feet to said North Section line; thence East, along said North Section line, a distance of 350.04 feet to the point of beginning. Said parcel contains 10.00 acres of land, more or less, excluding Minnesota Trunk Highway 14 right-of-way and is subject to existing easement of record.

Parcel #2 - Lot Ten (TO) of Block Four (4), Auditor's First Subdivision of Section Ten (10), Township One Hundred Nine (109) North, Range Forty four (44) West of the 5th P.M. and the West 100 feet of the East 642 feet of Lot One (1), Block Four (4) of the Auditor's First Subdivision of Section Ten (10), Township One Hundred Nine (109) North, Range Forty four (44) West of the 5th P.M.

Parcel #3 - Lot One (1) in Block number Two (2) of Auditor's First Subdivision of Section number Ten (10), Township One Hundred Nine (109) North, Range Forty four (44) West of the 5th P.M., Lincoln County, Minnesota, according to the Plat thereof filed and recorded in the Office of the County Recorder, formerly Register of Deeds, in and for said County.

Parcel #4 - The West 106 feet of Lot One (1) of Block Three (3) of Plat No. 1 of Auditor's First Subdivision of Section Ten (10), Township One Hundred Nine (109) North, of Range Forty four (44) West as measured parallel to the lot lines, according to the Plat thereof on file and of record in the Office of the County Recorder, formerly Register of Deeds, in and for said County and State; and

That tract or parcel of land being 30 feet in width and approximately 256 in length and being the alleyway between lots one (1) and two (2) of Block three (3) of the Auditor's First Subdivision of Section Ten (10), Township One Hundred Nine (109) North, Range Forty Four (44) West of the 5th P.M.

This Ordinance shall become effective upon publication.
