ORDINANCE NO. 107

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS
OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. That pursuant to Minnesota Statutes, Section 414.033, the City Council of the City of Watertown, having prior heretofore accepted a Petition for Annexation into the corporate limits of the City of Watertown by all of the property owners of those certain lands as hereinafter set forth and copies of said Petition having been filed with the Minnesota Municipal Board, the Board of Supervisors of the Town of Watertown, the Carver County Board of Commissioners, and the Secretary of State of the State of Minnesota on December 20, 1978, as required by law and the rules of the Minnesota Municipal Board, and the Town Board of Watertown Township having consented to said annexation and waiving the 90 day waiting period, and the Council having determined that said lands about the present corporate limits of the City of Watertown, that said lands are platted, are now urban or suburban in character, and are conditioned as properly to be subjected to municipal government and that annexation of said lands will be in the best interests of the City of Watertown and the lands to be annexed, the corporate limits of the City of Watertown are declared hereby extended to encompass and include all that certain land described as follows:

Outlot 26 and that part of Madison Street abutting and adjoining thereto, according to the plat of the Town of Watertown on file and of record in the office of the County Recorder, Carver County, Minnesota.

Section 2. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Town Clerk of the Town of Watertown, the Carver County Auditor, and the Minnesota Secretary of State and to publish this Ordinance in the Carver County News, all as required by law.
