Ladies and Gentlemen:



ORDINANCE NO. 215

## ORDINANCE ANNEXING ADJOINING LANDS

The City Council of the City of Madison does ordain:

Section 1. That the following described land adjoining the northern limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

LOT FOURTEEN (14) AND FIFTEEN (15), EXCEPT THE SOUTH TWO HUNDRED (S200') FEET AND THE NORTH SEVEN HUNDRED FORTY (N740') FEET THEREOF IN KJOSNESS ADDITION TO THE CITY OF MADISON, ACCORDING TO THE PLAT THEREOF ON FILE AND OF RECORD IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY AND STATE.

Section 2. That on the taking effect of this ordinance the corporate limits and boundary lines of the City of Madison shall be and are extended to include said tracts of land.

Section 3. This ordinance shall be in full force thirty (30) days from and after it's passage.
