ORDINANCE 2367

Introduced by Councilman Arliss D. Bachtle

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF ALBERT LEA TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA
ABUTTING UPON THE CITY LIMITS, SE $\frac{1}{2}$ OF SEC. 21

WHEREAS, a certain petition dated October 10, 1978, requesting
annexation of the territory hereinafter described was duly presented to
the Council on the 10th day of October, 1978; and

WHEREAS, the quantity of land embraced within the area described
in the petition and bounded as described is .85 acres of unplatted land,
no part of which is included within the limits of any incorporated city;
and,

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the
town board or the governing body of any municipality whose boundaries abut
upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city
limits at the westerly boundary thereof; now, therefore

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. The City Council hereby determines that the annexation will be
to the best interest of the City and of the territory affected; that the
territory hereinafter described abuts upon the city limits and is about to
become urban or suburban in character; that none of the said territory is now
included within the limits of any city.

Sec. 2. The corporate limits of the City are hereby extended to include
the unplatted land described as follows and the same is hereby annexed to and
included in the City as effectually as if it had originally been a part thereof:

Beginning at the NW Cor. of Lot 1, Block 2, Larsons First Addition;
thence westerly 120 feet;
thence southerly 175.55 feet;
thence easterly 120 feet;
thence northerly 175.55 feet;
all being a part of the SE $\frac{1}{4}$ Section 21, Township 102, Range 21 West, containing
.85 acres.

Sec. 3. The territory described is hereby zoned R-1 (single family
residence district):

Sec. 4. The City Clerk is hereby directed to file certified copies of
this ordinance with the Minnesota Municipal Commission, Secretary of State,
the town clerk and the county auditor.

Sec. 5. This ordinance takes affect upon its passage and publication
and the filing of the certified copies as directed in Section 4.

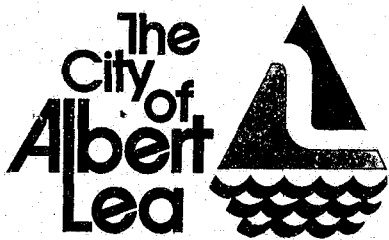
