PROPOSED ANNEXATION TO THE CITY OF MOORHEAD

Gentlemen:

The Town Board of Moorhead Township, Clay County, pursuant to a resolution duly adopted by the Town Board on Jan 22, 1979, hereby states that Moorhead Township has no objection to the annexation of the following described land to the City of Moorhead and hereby waives the 90 days before a city ordinance can be adopted.

That part of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Twenty-one (21), Township One Hundred Thirty-nine (139), Range Forty-eight (48), West of the Fifth Principal Meridian, Clay County, Minnesota, described as follows: Commencing at the point of intersection of the South right-of-way line of 30th Avenue South, and the East right-of-way line of 14th Street South, thence South 350 feet along the East right-of-way line of 14th Street South; thence East 250 feet parallel to the South right-of-way line of 30th Avenue South; thence North 350 feet parallel to the East right-of-way line of 14th Street South to the South right-of-way line of 30th Avenue South; thence West 250 feet along the South right-of-way line of 30th Avenue South to the point of beginning.
