ORDINANCE NO. 706

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

Willmar

WHEREAS, a petition has been filed with the governing body of the City of Willmar, a municipal corporation in the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota; and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Willmar, said property all of which said property is in Kandiyohi County, Minnesota; and

WHEREAS, pursuant to Minnesota law, said land may be annexed by ordinance; and

WHEREAS, the said property to be annexed consists of approximately 5 acres, more or less, described as follows, to-wit:

That part of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty-One (21), Township One Hundred Nineteen (119), Range Thirty-five (35), described as follows, to-wit: Beginning at the point of intersection of the South line of State Highway No. 23 and the East line of said Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), thence running South along the East line of said Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), a distance of 217 feet to a point, thence running West and parallel with the North line of said Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), a distance of 100 feet to a point on the South line of State Highway No. 23, thence East on said South line of said Highway to the point of beginning.

NOW, THEREFORE, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. *Best Interest of the City of Willmar and Area to be Annexed.* That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. *Abuts on City Limits.* That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. *Annexation.* That said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it has originally been a part of thereof.

Section 4. *Zoning.* The area above described shall be zoned R-2, One and Two Family Residential Districts.

Section 5. *Effective Date.* This Ordinance shall be filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of State of the State of Minnesota, and from and after its passage and publication.




