**ORDINANCE NO. 704**

**An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.**

WHEREAS, a petition has been filed with the governing body of the City of Willmar, a municipal corporation in the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota; and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Willmar, said property all of which said property is in Kandiyohi County, Minnesota; and

WHEREAS, pursuant to Minnesota law, said land may be annexed by ordinance; and

WHEREAS, the said property to be annexed consists of approximately 2.4 acres, more or less, described as follows, to-wit:

All that part of the S $\frac{1}{2}$  of the NE $\frac{1}{4}$  of Section 8, Township 119, Range 35, described as follows: Beginning at the Southeast corner of said NE $\frac{1}{4}$ ; thence on an assumed bearing of N 1° 55' 45" E, along the East line of said Section 8, a distance of 70.02 feet to the intersection with a line 70.00 feet North of and parallel with the South line of said NE $\frac{1}{4}$ ; thence on a bearing of N 89° 25' 36" W, along last said line 1329.25 feet; thence Southwesterly 132.06 feet, along a tangent curve concave to the Southeast, having a radius of 160.99 feet and a central angle of 47°; thence on a bearing of S 43° 34' 24" W, tangent to last said curve 25.73 feet to the South line of said NE $\frac{1}{4}$ ; thence on an assumed bearing of S 89° 25' 36" E, along said South line 1462.88 feet to the point of beginning.

NOW, THEREFORE, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. *Best Interest of the City of Willmar and Area to be Annexed.* That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. *Abuts on City Limits.* That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. *Annexation.* That the said property is hereby annexed to, and included within the City of Willmar, Minnesota, as effectually as if it has originally been a part thereof.

Section 4. *Zoning.* The area above described shall be zoned R-2, One and Two Family Residential District.

Section 5. *Effective Date.* This Ordinance shall be filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of State of the State of Minnesota, and from and after its passage and publication.


