Ladies and Gentlemen:



AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF WASECA, MINNESOTA, AND ESTABLISHING THE ZONING THEREOF.

WHEREAS, the land hereinafter described is unplatted land of less than 200 acres situated in Woodville Township, Waseca County, Minnesota, which abuts upon the corporate boundary of the City of Waseca and is hereby deemed to be urban in character within the meaning of Minnesota Statutes Annotated Section 414.033, Subd. 5, and

WHEREAS on September 22, 1978, all of the owners of said land have petitioned to the Council of the City of Waseca to have the land hereinafter described annexed to and included within the corporate limits of the City of Waseca; and

WHEREAS a notice of intent to annex the hereinafter described land has been served upon the Town Board of Woodville Township, and 60 days have passed without said Town Board submitting written objections to the annexation to the Commission, and said Township Board has waived any objection to said annexation or public hearings for same and that no objections thereto have been forthcoming, and

WHEREAS, the Council of the City of Waseca has determined that the annexation of said land will be to the best interest of the city and of the territory affected.

NOW, THEREFORE, BE IT RESOLVED that, pursuant to the provisions of Minnesota Statutes Annotated Section 414.033:

THE CITY OF WASECA DOES ORDAIN:

Section 1. That there is hereby annexed to and included within the corporate limits of the City of Waseca, the following described land in the County of Waseca and State of Minnesota, to-wit:

Including abutting roadways, All that part of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 5, Township 107 North, Range 22 West, Waseca County, Minnesota, described as:

Commencing at the Southwest corner thereof; thence north 00.0 degrees east, assumed bearing, eight hundred eighty-six (886) feet along the west line of said Section 5 to the true point of beginning, said last point being six and six/tenths (6.6) feet east of the centerline of Trunk Highway No. 13; thence north 90 degrees east, three hundred twenty (320) feet; thence north forty-nine (49) feet more or less to the centerline of County Ditch No. 9; thence northwesterly along the centerline of said Ditch to the said west line of Section 5, said point being south 0 degrees east approximately one hundred twenty (120) feet from the north line of the said Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of said Section 5, and said last course being contiguous with that property heretofore admitted to the City of Waseca by Ordinance No. 436; thence south along the west line of said Section 5 to the point of beginning, containing 1.15 acres more or less.

Section 2. All of the land described in Section 1 hereof shall be zoned Residential District within the meaning of the Zoning Ordinance of the City of Waseca, Minnesota.

Section 3. That a copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Clerk of the Woodville Township Board, the Auditor and Register of Deeds of the County of Waseca, Minnesota, and the Secretary of the State of Minnesota.

Section 4. This Ordinance shall take effect 10 days after its legal publication.
