ORDINANCE

An ordinance annexing certain property to the City of Brownton.

The City Council of the City of Brownton do ordain as follows:

That the premises adjoining the city limits of this city and described as follows:

Beginning at a point two rods East of the center of the Northwest Quarter of Section 32 in Township 115, Range 29; thence North 20 rods; thence East 16 rods; thence South 20 rods; and thence West 16 rods to the place of beginning.

And also the following tract:

Commencing at a point in the center of the Northwest Quarter [being the corner of Northeast Quarter of the Northwest Quarter, the Southeast Quarter of the Northwest Quarter and the Southwest Quarter of the Northwest Quarter and the Northwest Quarter of the Northwest Quarter] of Section 32 in Township 115, Range 29; thence East two rods to point of beginning; thence South 20 rods along line of public highway; thence East 16 rods; thence North 20 rods; thence West 16 rods to place of beginning, containing two acres.

May be, and the same hereby are incorporated within the limits of the City of Brownton, McLeod County, Minnesota.
