Ladies and Gentlemen:



ORDINANCE NO. 424

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA.

The City Council of the City of Ortonville, Minnesota does ordain:

Section 1: That it will be for the best interest of the City of Ortonville that the annexation herein be granted.

Section 2: That the following described premises abutting the municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

All that part of Government Lot 4 of Section Five (5), Township One Hundred Twenty-one (121) North, Range Forty-six (46) West of the Fifth Principal Meridian, bounded as follows:

Beginning at the Northeast corner of Outlot 1 of said Government Lot 4, thence North along the East line of said Government Lot 4 -- 804 feet; thence West at an angle of 90° -- 786 feet to the easterly line of Outlot 2 of said Government Lot 4; thence southeasterly along the easterly line of said Outlot 2 to an iron stake at the Northwesterly corner of said Outlot 1; thence east along the North line of Outlot 1 -- 510 feet to the place of beginning, EXCEPTING THEREFROM Outlot Three (3) of Government Lot Four (4)

AND

Outlot One (1), (EXCEPT THE SOUTH 62'), of Government Lot Four (4), Section Five (5), Township One Hundred Twenty-one (121) North, Range Forty-six (46) West of the Fifth Principal Meridian,

Section 3: This Ordinance shall be in force and effect from and after its passage and publication according to law.
