ORINANCE NUMBER 1979-3

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBANY, STEARNS COUNTY, MINNESOTA TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA AND ABUTTING UPON THE CITY LIMITS.

WHEREAS, certain petitions dated January 20, 1979 and February 5, 1979 requesting annexation of the territory hereinafter described was duly presented to the council on the 19th day of February, 1979; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, the Albany town board has waived the 90 day waiting period for adopting this ordinance; and

WHEREAS, the land described in the peitions abuts upon the city limits on its westerly boundries;

The Council of the City of Albany, Stearns County, Minnesota ordains:

SECTION I. The city counci hereby has determined

- (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and
- (2) that none of the territory is now included within the limits of any city.

SECTION II. TERRITORY ANNEXED.

The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if had originally been a part thereof:

ALL THAT PART OF THE SOUTH ONE-HALF (S12) OF SECTION 16, TOWNSHIP 125 NORTH, RANGE 31 WEST, STEARNS COUNTY, MINNESOTA DESCRIBED AS FOLLOWS: BEGINNING AT THE POINT OF INTERSECTION OF THE SOUTHERLY RIGHT OF WAY LINE OF THE BURLINGTON NORTHERN RAILROAD AND THE WEST LINE OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER (SE! SW!.) OF SAID SECTION 16; THENCE NORTHERLY, ALONG SAID WEST LINE AND THE WEST LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER (NEએ SWA) OF SAID SECTION 16, A DISTANCE OF 884.03 FEET TO THE SOUTHERLY RIGHT OF WAY LINE OF THE SOO LINE RAILROAD; THENCE NORTHEASTERLY, ALONG SAID RIGHT OF WAY LINE, A DISTANCE OF 1511.03 FEET TO THE POINT OF INTERSECTION WITH THE EAST LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER (NEW SWW) OF SAID SECTION 16; THENCE SOUTHERLY, ALONG SAID EAST LINE, TO THE SOUTH-EAST CORNER OF SAID NEW SWA; THENCE EASTERLY, ALONG THE NORTH LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER (SW14 SE14) OF SAID SECTION 16, A DISTANCE OF 300.00 FEET TO THE NORTHWEST CORNER OF HALLS HIGHVIEW ADDITION, ACCORDING TO THE PLAT ON FILE AND OF RECORD; THENCE SOUTHERLY, ALONG THE WEST LINE OF SAID ADDITION, TO THE NORTHERLY RIGHT OF WAY LINE OF SAID BURLINGTON NORTHERN RAILROAD; THENCE SOUTHEASTERLY, ALONG SAID NORTHERLY RIGHT OF WAY LINE, 1650 FEET, MORE OR LESS, TO THE POINT OF INTERSECTION WITH THE EXISTING CORPORATE LIMIT LINE OF THE CITY OF ALBANY; THENCE SOUTHERLY ALONG SAID CORPORATE LIMIT LINE TO THE SOUTHERLY RIGHT OF WAY LINE OF SAID BURLINGTON NORTHERN RAILROAD; THENCE NORTHWESTERLY, ALONG SAID SOUTHERLY RIGHT OF WAY LINE, 3300 FEET, MORE OR LESS, TO THE POINT OF BEGINNING AND THERE TERMINATING. CONTAINING 51.33 ACRES, MORE OR LESS.

SECTION III. FILING.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.


SECTION IV. EFFECTIVE DATE.

I, the under signed, being the duly qualifed and acting clerk in and for the City of Albany, Stearns County, Minnesota do hereby certify the the following excertps for the council meetings of February 19, 1979 and March 14, 1979 as it relates to matters for an annexation to the city are a true and exact copy of the original on file in my office in the official minute book. February 19, 1979

The following exerpt is from a duly called regular meeting held on the 19th day of February, 1979 at 6:30 o'clock p.m. in the city councilroom. Present for the meeting were Mayor Wallace Wedel and Councilmembers: Ralph Gorecki, Robley Evans and Robert Hanauer; Ervin Kuper was absent.

"The Council took note of petitions for annexation from Albany Agri Systems, Inc.; Albany Industries, Inc. and Home Of The Future, Inc., to annex the territory known as the Industrial Park concicting of approximately 39.43 acres and lying due west of the westerly city limits between the right-of-ways south of the SooLine Railroad Tracks and north of the Burlington Northern Railroad tracks. After due discussion a motion was made by Robley Evans and seconded by Ralph Gorecki to accept the petitions for annexation with the following

- 1) Albany Industries shall make available to the City a site for the construction of a water tower at no cost to the City
- 2) Albany Industries shall provide the city with the use of its land for the construction of a water tower by granting the City a construction easement at no cost
- 3) Albany Industries shall provide for the City a permanent access easement to the water tower and a utility easement for the trunk (line) water distribution line from the tower to the rest of the distribution system.

As soon as Albany Industries agrees to the stipulations the clerk is directed to proceed with the annexation. All voted for the motion and it carried."

March 14, 1979

The following exerpt is from a duly called special meeting held on the 14th day of March, 1979 in the council room at 7:30 o'clock p.m.; as it relates to matters for an annexation to the city and stipulations set forth at the meeting of February 19, 1979. Present for the meeting were: Mayor Wallace Wedel and Council members: Ralph Gorecki, Robley Evans and Robert Hanauer; Ervin Kuper was absent.

"Ervin Sand and Dr. R. C. Schwegler appeared before the Council as officers fo Albany Industries, Inc. to discuss the stipulations for annexation as set forth in the minutes of the council meeting dated February 19, 1979.

After due discussion a motion was made by Robley Evans and seconded by Robert Hanauer to defer the special assessments against Albany Industries, Inc. that will result from the construction of a water tower in the industrial park until such property is conveyed to another holder with such deferred assessments to accrue interest at the rate assigned to the (bond) issue so deferred. All of the other specifications listed in the minutes of the council meeting dated February 19, 1979 shall remain in place. All voted for the motion and it carried."

RE: ANNEXATION OF RAILROAD PROPERTY

Dear Mr. Shane:

This letter is to confirm our telephone conversation of this date.

The City of Albany is in the process on annexing land that lies due North of the BN in Albany.

At the present time about 900 feet of BN property juts into the City as rural property and this causes some problems with the enforcement of our zoning ordinance.

With the new annexation the BN property that would remain rural will be a half mile or more. The City would like to incorporate this property into the city limits.

The least bothersome way to accomplish this as far as the BN property is concerned is to annex the other parcel of land and then let the city exercise its power to annex the said land by simple ordinance at a later date. In this manner there is no paper work on your part and we will send you a copy of the ordinance after the fact.
