## ORDINANCE NO. 1344

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED LAND ABUTTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated December 26, 1978, requesting annexation of the territory described herein was duly presented to the Common Council on the 2nd day of January, 1979, and,

WHEREAS, the quantity of land embraced within the area described in the petition is approximately 1.04 acres of unplatted and platted land, no part of which is included within the limits of any incorporated city, village, or borough, and,

WHEREAS, the petition was signed by all the owners, and,

WHEREAS, no objections to annexation have been received from the Town Board, the County Board, or the governing body of any municipalities whose boundaries abut upon the land to be annexed, and,

WHEREAS, the land described hereinafter abuts the City limits on the west boundary thereof.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION I: The City Council hereby determines that the annexation will be in the best interest to the City and the territory affected. That the territory described herein abuts the City limits and is urban or suburban in character and that none of said territory is now included within the limits of any city, village, or borough.

SECTION II: The Corporate Limits of the City of Austin are hereby extended to include the platted land described as follows, the same is hereby annexed to, and included within the City as affectionally as if it had originally been a part thereof:

> Lots 4 and 5 in Block 1 of Southern Heights First Addition in Outlots 4 to 9 of subdivision of Outlots 11 to 32 inclusive in the northeast quarter of Section 9, Township 102 North, Range 18 West, Mower County Minnesota, including one half of the street right-of-way adjacent to these lots.

Also, the tract of land described as follows:

Commencing at the northwest corner of said Lot 5 in said Southern Heights First Addition; thence northeasterly on the west line of Lot 5 extended to the center of Turtle Creek; thence southeasterly along the center line of Turtle Creek as the same winds and turns to a point intersected by the east line of Lot 4 in said Southern Heights First Addition extended; thence southwesterly on the east line of said bot 4 extended to the northeast corner of Lot 4; thence northwesterly along the north line of said Lots 4 and 5 to the point of beginning.

SECTION III: The City Recorder is hereby directed to file certified copies of said Ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, County Auditor, Registrar of Deeds, Austin Utilities, and the Secretary of State.

SECTION IV: The ordinance takes affect upon its passage and publication, filing of certified copies as directed within Section III.
