

FLOODWOOD CITY ORDINANCE

NO. 150

BY COUNCILMAN KARKELA .

AN ORDINANCE  
FOR THE ANNEXATION OF CERTAIN  
PROPERTY BY THE CITY OF FLOODWOOD

The City Council of the City of Floodwood does ordain:

The City of Floodwood in the County of St. Louis, State of Minnesota, a municipal corporation, being the sole owner of the land hereinafter described, which land is contiguous with the present city limits does hereby annex and incorporate within its boundaries the following described land located in St. Louis County, Minnesota, to-wit:

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6), and Seven (7), in Block One (1), LUOMA'S SUBDIVISION, and that part of Government Lot Four (4), Section Eight (8), Township Fifty-one (51) North, Range Twenty (20), West of the Fourth Principal Meridian, described as follows, to-wit:

Starting at the NW corner of Section 8 and going south on the section line a distance of 838 feet more or less to the south line of Luoma's Subdivision, the point of beginning: thence to the east traveling in an easterly direction a distance of 790 feet along the south boundary line of Luoma's Subdivision to the southeast corner of said Luoma's Subdivision, thence going at right angles southerly a distance of 550 feet more or less; thence in a westerly direction along the river bed of the Savannah River to the aforementioned section line; thence on an angle to the north along the said section line a distance of 481.65 feet more or less to the point of beginning, containing 7 acres more or less.

Said property now being unincorporated.

This ordinance shall take effect from and after its passage and publication.


Councilman Karkela moved the passage of the ordinance and it was declared passed upon the following vote:


