AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, A certain Petition dated March 19, 1979, requesting annexation of the territory hereinafter described was duly presented to the Council on the 19th day of March, 1979; and,

WHEREAS, The quantity of land embraced within the area described in the Petition is less than 5 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and,

WHEREAS, The Petition was signed by all of the owners of said land; and,

WHEREAS, No objections to the annexation have been received from the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and the Town Board of Helen Township has consented to the annexation, and has waived its right to object to the annexation; and,

WHEREAS, No hearing is required by law on the proposed annexation; and,

WHEREAS, The land described in the Petition abuts upon the city limits at the Southeastern boundary thereof; the Council of the City of Glencoe, Minnesota, ordains:

SECTION 1. The City Council hereby determines (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

<u>SECTION 2.</u> Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been

a part thereof:

That part of the Northwest Quarter of the Southwest Quarter of Section Eighteen (18) in Township One Hundred and Fifteen (115) North of Range Twenty-seven (27) West, described as follows, to-wit: Beginning at the West Quarter Corner of said Section 18, thence South along the West line of said Section 18, for a distance of 186.60 feet, more or less to the Southerly right-of-way line of Minnesota Trunk Highway No. 212-12, being the actual point of beginning of the tract to be described: thence continuing South along the West line of said Section 18, for a distance of 419.55 feet; thence East at right angles, for a distance of 188.41 feet; thence North parallel with said West line of said Section 18, for a distance of 505.17 feet, more or less, to said Southerly right-of-way line of Minnesota Trunk Highway No. 212-12; thence Southwesterly along said Southerly right-of-way line, for a distance of 206.90 feet, more or less, to the actual point of beginning.

<u>SECTION 3.</u> Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota
Municipal Board, the Secretary of State, and the County Auditor, and the Town Board of Helen Township, and the County Recorder.

<u>SECTION 4.</u> Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
