ORDINANCE NO. 179

AN ORDINANCE TO AMEND ORDINANCE NUMBER 178 ON EXTENDING THE CORPORATE LIMITS OF THE CITY OF LE CENTER, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON AND SURROUNDED BY THE LIMITS OF THE CITY OF LE CENTER.

WHEREAS, THE territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory abuts and is surrounded by the SOUTHWESTERN Boundary thereof the corporate limits of the city and is deemed to be urban in character;

The corporate limits of the City of Le Center are hereby extended to include the platted property described as follows:

All that part of the southeast quarter of the Southwest quarter of section No. 29, Township No. 111 North Range No. 24 West, Le Sueur County, Minnesota described as follows: Beginning at a point on the East line of the Southwest quarter of said section No. 29, said point beginning 264.0 feet North of the South quarter corner of said section No. 29, thence West 117.0 feet, thence South 128.0 feet, thence West 203.0 feet, thence south 61.0 feet, thence West 175.0 feet, thence North 188.0 feet, thence West 165.0 feet, thence North 430.00 feet, thence East 660.0 feet, to the East line of said Southwest quarter, thence South on said East line 430.0 feet to place of beginning. Containing 6.30 acres.

Ordinance Number 178 is hereby amended.

This ordinance takes effect upon its passage and publication and the filing of certified copies as directed by law.

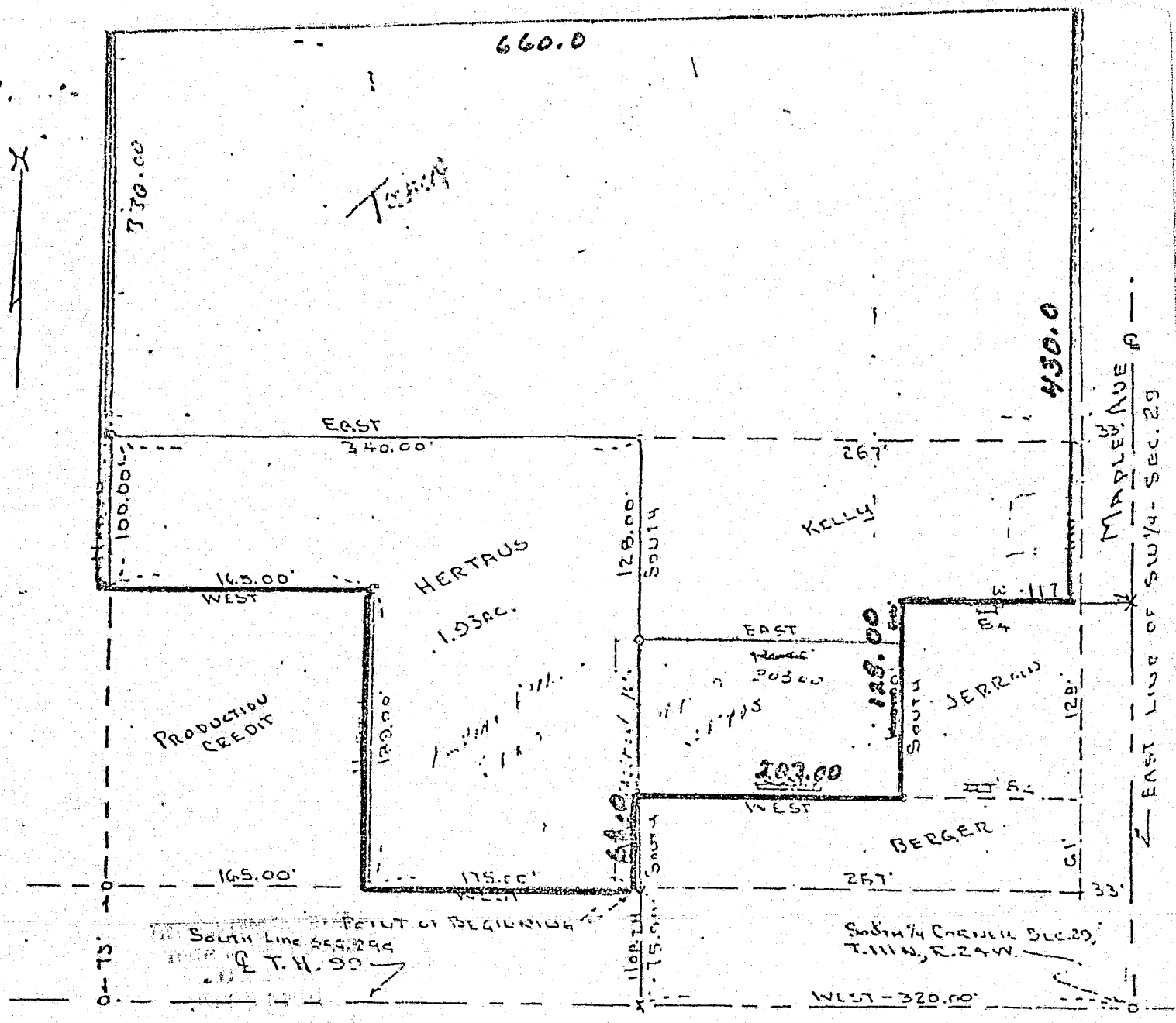
