Ladies and Gentlemen:



AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO
BE ANNEXED TO THE CITY OF ST. JAMES, MINNESOTA

BE IT ORDAINED By the City of St. James, Minnesota, as
follows:


(1) The following tracts of land lying adjacent to the
City of St. James and being in the County of Watonwan and
described as follows:

The North 467.38 feet of the South 542.38 feet of
the West 506.00 feet of Government Lot 15, located
in Section 18, Township 106, Range 31, Watonwan
County, Minnesota, consisting of approximately five
(5) acres.

together with all public rights of way, roads, railroad right
of way or waterways within, adjacent, or abutting upon said land,
are hereby annexed and declared to be a part of the City of
St. James and to be included in the corporate limits thereof.

(2) This Ordinance shall take effect from and after its
date of passage and publication.
