## ORDINANCE NO. <u>1 Series</u> 3

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WADENA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY OF WADENA.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City of Wadena at the South boundary thereof and is deemed to be urban in character; and WHEREAS, this territory is owned in fee by the City of Wadena:

The Wadena City Council of Wadena ordains:

<u>Section 1</u>. <u>Territory Annexed</u>. The corporate limits of the City of Wadena are hereby extended to include the unplatted property described as follows now owned by the City of Wadena:

That part of the West Half of the Northeast Quarter, (W<sup>1</sup>/<sub>2</sub> of NE<sup>1</sup>/<sub>4</sub>), of Section Seventeen (17) in Township One Hundred Thirty-four (134) North, Range Thirty-five (35) West of the Fifth Principal Meridian lying and being east of Wadena County Aid Road No. 104 (formerly County Aid Road No. 151) as the same laid out and existing, containing 28 acres.

<u>Section 2.</u> <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, Wadena Township Board, Wadena County Auditor, and the Minnesota Municipal Commission.


<u>Section 3.</u> Effective Date of Annexation. This ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section 2.




