EXHIBIT L.

To your Honorable Board of County Commissioners,
of the County of Hennepin and State of Minnesota.

The undersigned, your petitioners, legal voters of the Township of Minnetrista and Township of Excelsior, and residents upon the lands herein described and to be incorporated in the County of Hennepin and State of Minnesota, desire to organize and incorporate into a village the said present Township of Minnetrista and the said present Township of Excelsior in said County and State as hereinafter described under and pursuant to Sections 1204 to 1210 both inclusive, Chapter Nine (9) General Statutes 1913 and acts amendatory thereto.

In pursuance thereto your petitioners would set forth the following facts:-

First:- That the name of the proposed village shall be Island Park.

Second:- That the number of persons actually residing in said territory is 500 which said fact has been duly ascertained by a census of the population of the residents of said herein described territory, taken August 30th, 1924; Sept. 13, 1924, by H. C. Putman, Thos. C. Benson, Herman Johnson, C. L. Dowell, J. L. Bird, C. B. Raitz and John L. Losie, seven (7) of your petitioners then and there acting under the direction of the undersigned petitioners.

Third:- That the quantity of land to be included in said village be the same as that included in said Minnetrista Township and Excelsior Township of Phelps Island, which is Six Hundred (600) Acres more or less according to the United States Government Survey thereof.

Fourth:- That the boundaries and description of said territory are as described in Exhibit A, which is hereto attached and made a part of this petition.

There were cast "For Incorporation, No" 82 Votes.


