ORDINANCE NO. 155

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FOLEY TO INCLUDE CERTAIN UNINCORPORATED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated October 2, 1978 requesting the annexation of the territory hereinafter described was duly presented to the council on the 13th day of November, 1978; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is two (2) acres of land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, the Board of Supervisors of the Township of Gilmanton have withdrawn their objections to the annexation and no objections to such annexation have been received from the County Board of the governing board of any municipality whose boundaries abut upon the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Easterly boundary thereof;

THE COUNCIL OF THE CITY OF FOLEY, MINNESOTA, ORDAINS:

Section 1. That the City Council hereby determines that the annexation will be in the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City of Foley are hereby extended to include land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part hereof:

The North 295.2 feet of the East 295.2 feet of the West 723.2 feet of the Northwest Quarter of the Northwest Quarter (NW% of NW%) of Section Thirty-six (36), Township Thirty-seven (37), Range Twenty-nine (29), containing 2 acres, more or less.

Section 3. Filing. The city clerk is hereby directed to file certified copy of the ordinance with the Municipal Board, the Secretary of State, the County Auditor and the Gilmanton Township Clerk.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3.
