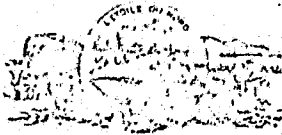

ORDINANCE ANNEXING CERTAIN REAL PROPERTY TO QUAMBA, MINNESOTA

WHEREAS, the City Council of Quamba, Minnesota, is empowered by authority of Minnesota Statutes, Chapter 414, to annex real property pursuant to the provisions therein; and

WHEREAS, a Petition to annex real property described as the Southeast Quarter of Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ), Section 35, Township 40, Range 23, Kanabec County, Minnesota, has been received by the City Council of Quamba, Minnesota, and

WHEREAS, 90 days have passed since the Petition was received by the City Council, and

WHEREAS, the Petition is signed by all of the owners of the real property to be annexed, and

WHEREAS, the real property sought to be annexed is suburban in character and the annexation shall benefit the City of Quamba;

NOW THEREFORE, the City Council of the City of Quamba, State of Minnesota, does ordain that the Southeast Quarter of Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ), Section 35, Township 40, Range 23, Kanabec County, Minnesota, is hereby annexed to the City of Quamba, Minnesota, and is a part thereof henceforth.


