COMMISSIONER'S SCIENTIFIC AND NATURAL AREAS ORDER NO. 9

WHEREAS THE LANDS IN SHERBURNE COUNTY DESCRIBED AS:
Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) of
Section Twenty-three (23), Township Thirty-four (34) North, Range
Thirty (30) West; Government Lot One (1) of Section Twenty-two
(22), Township Thirty-four (34) North, Range Thirty (30) West;
and, A piece of land 20 rods square in the Southeast corner of the
Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4) of Section
Fourteen (14), Township Thirty-four (34) North, Range Thirty (30)
West, described as: Commencing at a point on the South line of
said Section Fourteen (14), 20 rods West of the Southeast corner
of the Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4)
of said Section Fourteen (14), thence running West on said section
line to the Southwest corner of said Section Fourteen (14), thence
on the West line of said Section Fourteen (14), 20 rods, thence
running at right angles East to a point 20 rods due North of the
above mentioned starting point thence South to the place of beginning;
contain natural features of exceptional scientific and educational
value significantly illustrating geological formations, an undisturbed
plant community maintaining itself under prevailing conditions typical
of Minnesota, a seasonal haven for concentrations of waterfowl and
other birds, and an ecological community significantly illustrating
the processes of succession.

AND, WHEREAS, The most effective means by which such lands
can be used and protected for educational and research purposes in
such manner and by such means as will leave them conserved for future
generations is by designation as a Scientific and Natural Area.

NOW, THEREFORE: I, Joseph N. Alexander, Commissioner of
the Department of Natural Resources, pursuant to authority vested

in me by law, do hereby designate the above described lands as Clearlake-Mississippi Scenic and Recreational River Scientific and Natural Area. Furthermore, Clearlake-Mississippi Scenic and Recreational River Scientific and Natural Area is designated as a Public Use Unit, limiting use to programs conducted by qualified scientists and graduate and post graduate students, programs for primary and secondary, and college undergraduate students and interpretive programs for the benefit of the general public.


IT IS FURTHER ORDERED that the provisions of NR 300 through and including NR 303 shall apply to the use of the above designated area.


