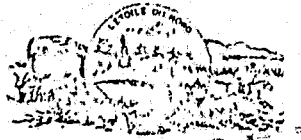





## Legal Notice

**Ordinance No. 66**  
**AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BUFFALO LAKE, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.**

WHEREAS, a certain petition dated October 17, 1978, requesting annexation of the territory hereinafter described was duly presented to the council on the 2nd day of November, 1978; and

WHEREAS, the petition was signed by all of the owners of the territory hereinafter described; and

WHEREAS, no objections to

the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the easterly boundary thereof;

The council of the City of Buffalo Lake, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character, and (2) that none of the territory is now included within the limits of any city.

Section 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to

include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it has originally been a part thereof:

All the tract or parcel of land lying and being in the County of Renville and State of Minnesota, described as follows:

That part of the West 40 Rods which is South of the right-of-way of the Chicago-Milwaukee-St. Paul & Pacific Ry. Co. in the Southwest Corner of the Southwest Quarter in Section 29, Township 115, Range 31, not including existing highway and railroad right-of-way, and

All that tract of land lying between the following described line and the Southerly right-of-way of the Chicago-Milwaukee-St. Paul & Pacific Ry. Co.: commencing at a point on the East line of the West One-half of Section 30, Township 115 North, Range 31 West, which is 120 feet South of the Center line of the right-of-way of the Chicago-Milwaukee-St. Paul & Pacific Ry. Co.; thence Easterly and parallel with the Center line of said right-of-way for a distance of 383 feet; thence Northerly and parallel with said East line of the West One-half of said Section 30 for a distance of 50 feet; thence Easterly and parallel with the center line of said right-of-way at a distance of 70 feet South therefrom to the East line of said Section 30.

Section 3. FILING. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance taken effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

The Minnesota Municipal Board has had pending for over six months the above-proposed annexation. It is the responsibility of the initiating party to fulfill the requirements checked below which must be met before the board may proceed with the filing of this annexation. However, under 414.033, Subd. 5, the city may assist the petitioners in complying with these requirements.

- ☐ Petition/Notice of Intent/Ordinance must be accompanied by a certification showing that it was filed with the affected town board, county board, council of any abutting municipality and the date filed.
- ☐ A map or plat should be forwarded to the Board showing the property in relationship to the municipality or specifically
- ☐ A filing fee of \$2.00 an acre with a minimum of \$50 and a maximum of \$300 is required to be filed with the Municipal Board.
- ☐ The property description is incorrect. Please file an amended Petition containing the correct description on all parties, as follows:
