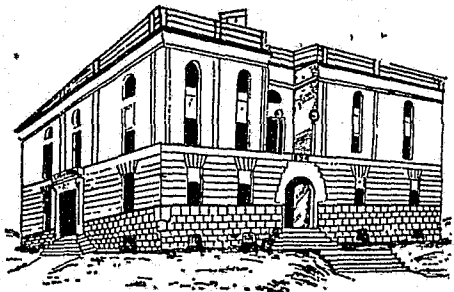

ORDINANCE 79-9

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

Whereas, a certain petition dated July 25, 1978, requesting annexation of territory described hereinafter was duly presented to the council of the City of Faribault, Minnesota, at a regular meeting thereof held on the 22nd day of May 1979, at 7:00 P.M., and was duly considered by that body; and

Whereas, the quantity of land embraced within the area described in said petition and bounded as described therein is approximately 194 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

Whereas, the petition was signed by all owners of such land; and

Whereas, no objections to such annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

Whereas, the town board of Warsaw Township, Rice County, Minnesota and the Board of County Commissioners of Rice County, Minnesota, have executed waivers of objections to the proposed annexation of land; and

Whereas, the land described in such petition abuts upon the city limits of the City of Faribault, Minnesota at the southerly boundary thereof; and

Whereas, such annexation will be to the best interests of the municipality and territory affected,

THE CITY OF FARIBAULT ORDAINS:

Section 1. DETERMINATION. The city council hereby determines (1) the annexation will be to the best interests of the city and of the territory affected; (2) the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) none of said territory is now included within the limits of any city, village, or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city of Faribault, Minnesota as effectually as if it had originally been a part thereof:

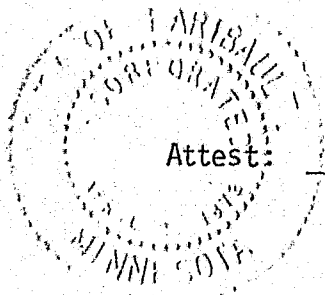
The North Three-fourths of the East One-half of Section 12, Township 109 North, Range 21 West of the Fifth Principal Meridian, Rice County, Minnesota, lying East of the Chicago, Milwaukee, St. Paul and Pacific Railroad; excepting therefrom the South 4 acres thereof; and excepting the following: Beginning at a point in the North line of the Northeast Quarter of Section 12, a distance of 566.59 feet westerly from the Northeast corner thereof; thence southerly at right angles to said North line of Northeast Quarter, 218.00 feet; thence westerly, parallel with and 218.00 feet southerly from said North line of Northeast Quarter, 200.00 feet; thence northerly at right angles to said North line of Northeast Quarter, 218.00 feet to a point in said North line of Northeast Quarter; thence easterly, along said North line of Northeast Quarter, 200.00 feet to the point of beginning; subject to County State Aid Highway #18 over the northerly side thereof; subject also to easement of record.

Section 3. FILING. The city administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Rice County Auditor, and the Town Clerk of Warsaw Township.

Section 4. EFFECTIVE DATE OF ANNEXATION. This ordinance shall take effect and be in force 30 days from and after its passage and publication and the filing of certified copies as directed in Section 3.
