ORD. NO. 544
ORDINANCE ANNEXING CERTAIN LANDS
TO THE CITY OF MONTEVIDEO

WHEREAS, a petition has been filed with the City of Montevideo by owners of all the hereinafter described land requesting that said land be annexed to the City of Montevideo; and

WHEREAS, copies of said petition have been filed with the Minnesota Municipal Board, the Town Board of Sparta Township, and the County Board of Chippewa County; and

WHEREAS, Sparta Township has consented to said annexation and waived any objection thereto, which consent and waiver of objection are on file in writing with the City of Montevideo.

THE CITY OF MONTEVIDEO DOES ORDAIN:

1. That the City Council of the City of Montevideo finds and determines that the hereinafter described premises abut upon the City Limits of the City of Montevideo and are suburban in character and are susceptible to municipal control and development by the City of Montevideo and that the annexation of said premises to the City of Montevideo will be to the best interests of the City of Montevideo and the territory to be annexed.

2. That the tract of land in the County of Chippewa and State of Minnesota described as follows:

A parcel of land in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West commencing at a point thirty-three feet (33') East and thirty feet (30') South of the Northwest corner of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$), thence South and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) for a distance of one hundred sixty-one and two tenths feet (161.2') to the true point of beginning, thence East and parallel to the North line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of one hundred fifty feet (150'), thence South and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of two hundred sixty feet (260'), thence West and parallel to the North line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of one hundred fifty feet (150'), and thence North and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of two hundred sixty feet (260') to the true point of beginning, containing .9 acres more or less.

be and the same hereby is annexed to the City of Montevideo and is hereby incorporated into the corporate limits of said City pursuant to Minnesota Statutes 414.033, Subdivision 5.

3. That this Ordinance shall take effect 30 days from and after its passage and publication.

WAIVER

On this 15th day of June 1979, Sparta Township acknowledges the receipt of a copy of the Petition for the Annexation to the City of Montevideo that certain tract of land in the County of Chippewa and State of Minnesota, described as follows:

A parcel of land in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West commencing at a point thirty-three feet (33') East and thirty feet (30') South of the Northwest corner of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$), thence South and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) for a distance of one hundred sixty-one and two-tenths feet (161.2') to the true point of beginning, thence East and parallel to the North line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of one hundred fifty feet (150'), thence South and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of two hundred sixty feet (260'), thence West and parallel to the North line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of one hundred fifty feet (150'), and thence North and parallel to the West line of said Northwest Quarter of said Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of two hundred sixty feet (260') to the true point of beginning, containing .9 acres more or less.

The Township does hereby consent to said annexation and waives any objection thereto and hereby consents to the immediate annexation of said premises to the City of Montevideo without the City having to wait the ninety (90) days during which objections may be filed to said annexation.

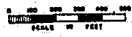
