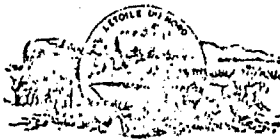

ORDINANCE ANNEXING LAND

WHEREAS, a petition has been filed with the City of Watson by all the owners of the hereinafter described lands requesting that said lands be annexed to the City of Watson; and

WHEREAS, copies of said petition have been filed with the Minnesota Municipal Board, the Town Board of Tunsberg Township and the County Board of Chippewa County; and

WHEREAS, the Town Board of Tunsberg Township has waived the ninety (90) days for the filing of objections and has consented to said annexation, copies of such Waiver and Consent being on file with the City of Watson and the Minnesota Municipal Board;

NOW, THEREFORE, THE CITY COUNCIL OF WATSON ORDAINS:

1. That the City Council of the City of Watson finds and determines that the hereinafter described premises abut upon the city limits of the City of Watson and are suburban in character and are susceptible to municipal control and development and that annexation of said premises to the City of Watson will be for the best interest of the City of Watson and the territory to be annexed.

2. That the certain tract of land in the County of Chippewa and State of Minnesota described as follows:

That part of the SE¼ of the NE¼ and that part of the NE¼ of the SE¼ of Section 21, Township 118, Range 41, described as follows: Beginning at the Northeast corner of Lot 6, Block Two of HIGHLAND RIDGE, as of public record, Chippewa County, Minnesota; thence on an assumed bearing of N 89° 38' 31" W, along the North line of said Lot 6, a distance of 130.00 feet; thence on a bearing of N 0° 21' 29" E, on the Northerly extension of the West line of said Lot 6, a distance of 56.51 feet; thence on a bearing of N 52° 17' W, 453.85 feet to the intersection with the Southwesterly extension of the Northwesterly line of Lot 1, of Block One of said HIGHLAND RIDGE; thence on a bearing of N 37° 43' E, along last said line 130.00 feet to the Southwesterly line of the Dedicated Road in said HIGHLAND RIDGE; thence on a bearing of S 52° 17' E, along last said line 460.80 feet; thence Southeasterly along last said line 106.52 feet, along a tangent curve concave to the Southwest having a radius of 115.94 feet and a Central angle of 52° 38' 29"; thence on a bearing of S 0° 21' 29" W, along last line, tangent to last said curve, 63.46 feet to the point of beginning, containing 1.70 acres, more or less, said premises to be platted as HIGHLAND RIDGE SECOND ADDITION.

be and the same hereby is annexed to the City of Watson and are hereby incorporated into the corporate limits of said City pursuant to Minnesota Statutes 414.033, Subdivision 5.


