ORDINANCE NO. 709

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, a petition has been filed with the governing body of the City of Willmar, a municipal corportion in the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota; and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Willmar, said property all of which
said property is in Kandiyohi County, Minnesota; and
WHEREAS, pursuant to Minnesota law, said land
may be annexed by ordinance; and

WHEREAS, the said property to be annexed consists of approximately 9.56 acres, more or less, described as follows, to-wit:

The North 550.00 feet of the West 750.00 feet of Government Lot 2, AND the South 35.00 feet of the West 750.00 feet of the SW1/4 of the NE1/4, all in Section 23, Township 119, Range 35, Kandiyohi County, Minnesota, except that part platted as Pleasant View Second Addition.

NOW, THEREFORE, the City Council of the City

of Willmar hereby determines, ordains and declares as

Area to be Annexd. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to City government...

Section 3. Annexation. That the said property is hereby annexed to and included within, the City of Willmar, Minnesota, as effectually as if it has originally been a part thereof.

Section 4. Zoning. The area above described shall be zoned R-2, One and Two Family Residential District.

Section 5. Effective Date. This Ordinance shall be filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyöhi, Minnesota and the Secretary of State of Minnesota, and from and after its passage and publication.
