ORDINANCE NO. 168

AN ORDINANCE ANNEXING CERTAIN  
LANDS TO THE CORPORATE  
LIMITS OF THE CITY OF OLIVIA

THE CITY COUNCIL OF THE CITY OF OLIVIA DOES ORDAIN:

Section 1: The following described land, abutting upon and contiguous with the present City boundary is hereby annexed and incorporated into the City for all purposes as though it had originally been a part thereof:

East 352 feet of the North 370 feet of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ), Section 18, Township 115, Range 34, subject to road right-of-way along easterly boundary thereof; being approximately 2.98 acres.

Section 2: Said annexation shall be effective from and after the publication of this ordinance, and the making of the required filings thereof, as provided by law.
