ORDINANCE NO. 32 ____, SECOND SERIES

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF REDWOOD FALLS.

THE CITY OF REDWOOD FALLS DOES ORDAIN:

- 1. That it is hereby found and determined:
- (a) That the lands hereinafter described abut on the City of Redwood Falls.
- (b) That said lands are less than two hundred acres in area and are unplatted, and that a petition for annexation of said lands to the City of Redwood Falls is on file in the office of the Redwood Falls City Administrator and has been signed by all of the ones of said lands.
 - (c) That said lands are urban in character.
- (d) That said lands are suitably conditioned for city government.
- (e) That it is for the best interests of the City of Redwood Falls and the owners and residents of said lands that the same be annexed to the City of Redwood Falls.
- 2. That the following described lands, lying and being in the County of Redwood, State of Minnesota, are hereby annexed to the City of Redwood Falls, to-wit:

All that part of the Northwest Quarter of the Southwest Quarter (NW\{SW\{\}}) of Section Thirty-six (36), Township One Hundred Thirteen (113) North, Range Thirty-six (36) West, described as follows:

Commencing at the Southwest corner of said Northwest
Quarter of the Southwest Quarter (NW&SW&) of
Section Thirty-six (36) and running thence North
along the West section line of said Section Thirtysix (36) a distance of 240 feet, thence East parallel
with the South line of said Northwest Quarter of
the Southwest Quarter (NW&SW&) of Section Thirtysix (36) a distance of 240 feet, thence South
parallel with the West line of said Section
Thirty-six (36) a distance of 240 feet, thence
West along the South line of said Northwest
Quarter of the Southwest Quarter (NW&SW&) of
Section Thirty-six (36) a distance of 240 feet to
the place of beginning.
