ORDINANCE NO. 5 2ND SERIES

AN ORDINANCE DECLARING AN EMERGENCY AND ANNEXING  
CERTAIN LANDS TO THE CITY OF REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

1. That this Council hereby finds and determines that an emergency exists requiring the passage of an Ordinance necessary for the immediate protection of the public health by reason of the fact that in order to obtain physicians and surgeons to care for the health of the residents of the City, it is necessary for the Redwood Medical Group to construct a clinic building on land now located outside the boundaries of the City; that such construction must be commenced immediately in order to insure completion thereof in the summer of 1976; that in order to permit the supplying of sewer and water service to said clinic building to be constructed, it is requisite that the same be located within the boundaries of the City; and that it is necessary to complete the construction of said clinic building during said period in order for said Redwood Medical Group to provide facilities for a sufficient number of doctors to care for the health of the residents of the City.

2. That it is hereby found and determined:

(a) That the lands hereinafter described abut on the City of Redwood Falls; that said lands are less than two hundred acres in area and are unplatted; and that a Petition for Annexation of said lands to the City of Redwood Falls is on file in the office of the Redwood Falls City Clerk and has been signed by all of the owners of said lands.

(b) That said lands are urban in character.

(c) That said lands are suitably conditioned for city government.

(d) That it is for the best interests of the City of Redwood Falls and the owners and residents of said lands that the same be annexed to the City of Redwood Falls.

3. That the following described lands lying and being in the County of Redwood, State of Minnesota, are hereby annexed to the City of Redwood Falls:

All that portion of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Six (6), Township One Hundred Twelve (112) North, Range Thirty-five (35) West lying North of the Chicago and Northwestern Railroad, South of Trunk Highway 93 and East of the center of County Ditch No. 52; more specifically described as: Commencing at the point of intersection of said Trunk Highway 93 and the Chicago Northwestern Railroad and running thence in a Northwestern direction 1,030 feet to the center of said County Ditch 52, thence in a generally Northerly direction 380 feet to the South line of said Trunk Highway 93, thence in a Southeasterly direction 1,225.7 feet to the point of beginning.
