ORDINANCE NUMBER 51

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF
NEW GERMANY TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED
LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

Whereas, a certain petition dated December 12, 1978 requesting annexation of the territory hereinafter described was duly presented to the council on the 12th day of December, 1978; and

Whereas, the petition was signed by all the owners of said land; and

Whereas, no objections to the annexation have been received from the town board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

Whereas, the land described in the petition abuts upon the city limits at the north boundary thereof;

The Council of the City of New Germany, Minnesota, ordains:

Section 1. The City Council hereby determines (1) That the territory described herein abuts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, said lands lying and being in the County of Carver, State of Minnesota and described as follows, to-wit:

Beginning at a point 1488.875 feet South of the Northwest corner of Section Four(4), Township One Hundred Sixteen (116), Range Twenty-Six (26) on the west section line; thence running East 430.1 feet; thence North 222.25 p arallel with the west s ection line; thence west 430.10 feet to a point on said west section line; thence south on west section line 222. 25 feet to place of beginning, situated in the West Half of the Northwest Quarter of Section 4, Township 116, Range 26 and containing 2.20 acres m ore or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance withthe Minnesota Municipal Board, the Secretary of State, the Town Cl rk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
