ORDINANCE NO. 186

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AITKIN, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED, PLATTED AND UNPLATTED LAND NOT EX-CEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS,

WHEREAS, a certain petition dated May 16, 1979, requesting the annexation of the territory hereinafter described, was duly presented to the Council on the 16th day of May, 1979; and

WHEREAS, the quantity of land embraced within the area described in the petition consists of approximately 12.87 acres of platted land and 16.69 acres of unplatted land, no part of which in included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was not signed by all the owners in fee of all of the real property within the area to be annexed; and

WHEREAS, a public hearing was held on June 18, 1979, at 7:00 P.M. at the Aitkin City Hall after 30 days mailed notice of said hearing was given to of said property owners; and

WHEREAS, no written objections to the annexation have been received from the County Board, the Town Board of Aitkin Township, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the existing City limits at and along the southerly boundaries of said existing City limits.

THE COUNCIL OF THE CITY OF AITKIN, MINNESOTA, ORDAINS:

Section 1. <u>Findings.</u> The City Council hereby determines (1) that the annexation will be to the best interests of the municipality and of the territory affected; (2) that the territory described herein abuts upon the existing City limits to the south and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.
