ORDINANCE NUMBER 1002 - 79

AN ORDINANCE TO ANNEX LAND TO THE  
CITY OF BENSON

WHEREAS, the real estate hereinafter described is 60% or more bordered by the City of Benson and is less than 40 acres in area and is unincorporated land abutting the City of Benson and is not included in any other municipality.

NOW THEREFORE, the City of Benson does ordain:

That the real estate hereinafter described be and the same hereby is annexed to the City of Benson of the County of Swift and State of Minnesota and that the corporate limits of the City of Benson be and hereby are extended to include said real estate which is situate in the County of Swift and State of Minnesota described as follows, to-wit:

Tract #1: All of the East Heights Addition, pursuant to the plat thereof on file in the office of the County Recorder of the County of Swift, State of Minnesota, which addition is a part of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) and the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ -SE $\frac{1}{4}$ ) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39), County of Swift, State of Minnesota, containing 9.2 acres more or less.

Tract #2: All that part of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39), County of Swift, State of Minnesota, described as follows: Commencing at a point 478.2' North of the Southwest corner of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39), which is the point of beginning; thence East a distance of 270 Feet; thence North a distance of 60'; thence East a distance of 1,050' more or less to the East line of the Southwest Quarter of the Northeast quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39); thence North along the East line of said Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) of Section Five (5) to the Northeast corner thereof; thence West along the North line of said Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) of Section Five (5) to the Northwest corner thereof; thence South along the West line of said Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ) of Section Five (5), to the point of beginning; excepting therefrom, however, all of Willow Knoll Addition to the City of Benson, Minnesota, which is located within the bounds of the above described tract of land; said Tract #2 herein contains 15 acres more or less.
