An Ordinance extending the corporate limits of the City of Chisago City, Minnesota.

WHEREAS the territory described below is not presently within the corporate limits of any incorporated, city village or borough, and,

WHEREAS the sole owner of the property described below petitioned the City Council of the City of Chisago City, Minnesota on the 5th day of March, 1979, to annex the same to the City of Chisago City, and,

WHEREAS, by resolution adopted by the City Council on June 26, 1979, and served upon the Chisago County Board of Commissioners, the Chisago Lakes Township Board and the Minnesota Municipal Commission by mailing a copy of same to each of them on the 20th day of March, 1979, the said City Council expressed its intention to annex the territory described below to said City, and,

WHEREAS no objections have been received from any party as to the proposed annexation.

NOW THEREFORE the City Council of the City of Chigago City, Chigago Carrier Carrier ordains as follows:


